SENTENCE: 21 months in prison, execution stayed for up to five years on the following conditions: (1) supervised probation for up to five years; (2) serve 180 days in jail, with credit for five days served; defendant may serve the jail sentence on work release or in-custody Sentence to Service, and criteria were waived; he should begin his work release or in-custody Sentence to Service jail sentence on June 9, 2009; (3) defendant to pay a \$200 fine and surcharges on a schedule to be determined by Court Administration; (4) defendant to pay restitution; (5) defendant to have no direct or indirect contact with victim, and will abide by the order for protection; (6) complete a Cognitive Skills Programming evaluation and following all recommendations; (7) follow all recommendations of the Human Services, Inc. psychological evaluation; (8) abstain from the use of mood-altering chemicals, including alcohol, and submit to random urinalyses at his own expense; (9) have no same or similar offenses, remain law abiding, and cooperate with probation; (10) cooperate with the transfer of supervision to the defendant's county of residence, and (11) provide a biological specimen for DNA analysis.

Have her medical prescriptions monitored by her probation officer.

SENTENCE: On the charge of felony theft over \$5,000, the Court committed the defendant to the Commissioner of Corrections for 17 months and stayed the execution of sentence and placed the defendant on probation for a period of five years under the following conditions: 1) Serve 113 days in the Washington County Jail with credit for 45 days served; 2) Pay a fine of \$50 plus surcharges. 3) Have no contact with any Target store. 4) Pay restitution in the amount of \$5,320.26 to Target Corporation through Washington County Court Administration; 5) Complete an evaluation for cognitive skills programming if available in his county of residence and follow all recommendations; 6) Complete a chemical dependency evaluation within 60 days of sentencing and follow all recommendations including aftercare plans; 7) Abstain from the use of all mood altering chemicals including alcohol and submit to random urinalysis/breathalyzers at his own expense; 8) Seek and maintain gainful employment and provide verification to the supervising probation officer; 9) Follow all the standard conditions of the intensive supervision unit if the defendant becomes a Washington County resident; 10) Have no same or similar offenses, be law abiding and cooperate with all the standard conditions of probation; and 11) Cooperate with the transfer of his supervision to his county/state of residence.
