SENTENCE: The defendant was committed to the Commissioner of Corrections for a period of 23 months, under a stay of execution of sentence and placed on probation for a period of 5 years, subject to the following conditions: (1) Serve 150 days in the Washington County Jail with credit for 2 days served, time to be served on work release, in or out-of-custody Sentence to Service, if qualified. Defendant was taken into custody for 24 hours of jail as the anniversary of the day of offense; (2) Pay restitution; (3) Follow all recommendations by Hazelden; (4) Abstain from the

use of all mood-altering chemicals, including alcohol, and submit to random urinalysis or breathalyzers at his own expense; (5) Attend AA/NA meetings 3 times per week for the duration of probation; (6) Attend MADD Victim Impact Panel; (7) Have no same or similar offenses, be law abiding, and cooperate with all the standard conditions of probation; (8) Cooperate with the transfer of his supervision to his county/state of residence; (9) Provide a biological specimen for purposes of DNA analysis; (10) \$100 fine.
