CONVICTION: Receiving Stolen Property  
SENTENCE: Committed to the Commissioner of Corrections for a period of 13 months. Further, the Court stays the execution of sentence and places Defendant on probation for 5 years under the following conditions: 1) Serve 90 days in jail with credit for 13 days served. 2) Pay \$50 fine plus surcharges. 3) No restitution. 4) Ordered to obtain a chemical dependency evaluation and follow all recommendations, including aftercare plans. 5) Ordered to abstain from the use of mood altering chemicals, including alcohol, and submit to random urinalysis/breathalyzers at his own expense. 6) Have no same or similar offenses, be law abiding, and cooperate with all the standard conditions of probation. 7) Cooperate with the transfer of his supervision to his County/State of residence. 8) Ordered to provide a biological specimen for purposes of DNA analysis.

probation agent; (5) complete a Cognitive Skills Program evaluation, if available in his county of residence, and follow all recommendations; (6) complete the in-jail treatment program, (7) abstain from the use of mood-altering chemicals, including alcohol, and submit to random urinalyses at his own expense; defendant must provide a baseline urinalysis today; (8) comply with all the standard conditions of the Intensive Probation Supervision Program, if he becomes a Washington County resident; (9) have no same or similar offenses, remain law abiding, and cooperate with standard conditions of probation; (10) cooperate with the transfer of supervision to his county of residence, and (11) provide a biological specimen for DNA analysis.

Controlled Substance Crime in the Fifth Degree: 17 months in prison, execution stayed for up to five years on the following conditions: (1) supervised probation for up to five years; (2) serve 365 days in jail, with credit for 148 days served, and defendant must report to jail no later than 4:30 p.m. on December 1, 2008; (3) the fine and surcharge were waived; (4) complete a Cognitive Skills evaluation, if available in his county of residence, and follow all recommendations; (5) complete the in-jail treatment program; (6) abstain from the use of mood-altering chemicals, including alcohol, and submit to random urinalyses at his own expense; (7) follow the standard conditions of the Intensive Probation Supervision Program; (8) have no same or similar offenses, remain law abiding, and cooperate with conditions of probation; (9) cooperate with the transfer of supervision to his county of residence, and (10) provide a biological specimen for DNA analysis.
