

Teeb Meem Los Ntawm Txoj Kev Tsis Mus Kawm Ntawv

Yog tus menyuam tseem tsis mus kawm ntawv ntxiv, ces rooj plaub yuav muab xa mus rau Kws Lij Choj hauv Nroog Washington County Attorney's Office txiav txim seb yuav ua li cas ntxiv mus. Lub sijhawm no, cov niam txiv los yog tus neeg muaj cai saib xyuas kuj muaj yuav raug lub txim los yog tias nws tswj tsis tau kom tus menyuam mus kawm ntawv. Tus menyuam yuav raug foob mus nrhiav kev pab rau nws txoj kev tsis kawm ntawv. Tus kws txiav txim plaub ntug muaj txoj kev cai rau ntau hom kev txim txhaum los yog kev txhaum uas muaj xws li nram no.

- Yuav tshem tus menyuam daim ntawv tsav tsheb kom txog thaum nws muaj hnuv nyoog 18 xyoo.
- Tus menyuam yuav raug zov (probation).
- Tus menyuam raug mus kawm ntawv los ntawm Kws Lij Choj.
- Tus menyuam muaj pheem raug mus txhuaj xyuas thiab kev txias txhuaj los yog kev soj ntsuam hlwb.
- Tus menyuam raug mus ua hauj lwm dawb pub nrog zej zog.
- Tsis pub tus menyuam tawm tau hauv nws lubtsev tsuas yog tawm mus kawm ntawv los yog tawm nrog nws niam nws txiv xwb.
- Tus menyuam raug tshem tawm hauv nws lubtsev mus nyob rau lwm qhov chaw mus ib ntus.
- Lubtsev txiav txim muaj cai ntsuam xyuas, los nrhiav kev pab txhawb zog.

Kev Pab Koj Menyuam Mus Kawm Ntawv

- Qhia koj cov menyuam tias kev kawm ntawv tseem ceeb npaum lis cas rau koj.
- Muaj sijhawm nrog koj cov menyuam lub caij yuav pws thiab sawv ntsov nrog kev noj tshais uake.
- Muaj kev sib tham nrog tsev kawm ntawv; yuav tsum paub tsev kawm ntawv txoj kev cais thiab yuav tawm suab rau koj cov menyuam pem tsev kawm ntawv.
- Kev saib xyuas kom koj cov menyuam ua lawv cov ntaub ntawv kom tiav txhuas hnuv.
- Pab koj cov menyuam kom lawv cov ntaub ntawv los yog nrhiav lwm tus pab lawv.
- Yuav ib lub moos kom tsa lawv sauv.
- Tsis txhob dag npog koj tus menyuam thaum nws tsis mus kawm ntawv.
- Yog tus menyuam tsis xav mus, nug tias vim licas thiab pab nrhiav kev pab koj cov menyuam qhov teeb meem.
- Qhia kom koj cov menyuam paub qhov koj xav tau thiab muaj caij nyoog los tsev.
- Nrhiav kev pab rau tej teeb meem ua yuav los raug rau nws kev mus kawm ntawv, xwslu kev soj ntsuam hlwb, quav yeeb quav tshuaj, los teeb meem ntawm cov hluas.

Mus Kawm Ntawv: Nws Yog Txoj Kev Cai

Xeev Minnesota txoj kev cai txwv kom menyuam yuav tsum mus kawm ntawv.

Truancy (tsis mus kawm ntawv) txhaum xeev Minnesota kev cai. Cov niam txiv, tsev kawm ntawv, thiab lub zej zog yog ib cov neeg koom tes ua txoj dejnum kom mus cuag lub ho phiaj txog kev mus kawm ntawv thiab kom muaj kev vam meej.

Kev kawm ntawv tseem ceeb li zaub mov, ris txho, thiab chaw nyob hauv ib tug menyuam lub neej. Niam txiv yuav tsum xav lawv cov menyuam mus kawm ntawv kom paub ua lawv lub neej kom zoo.

Txoj cai qhia kom niam txiv yuav tsum cob lawv cov menyuam mus kawm ntawv. Menyuaum rhov tsis tau lawv npe tawm ntawv los ntawn lawv tus kheej. Txoj kev qhaj ntawv thiab mus kawm tsis cuag ncuav yog qhov teem meem ua rau menyuam kawm tsis tiav raws sijhawm.

Qhov txim loj txhaj tsis yog los nrawm xam txiav txim rau cov menyuam ua tsis mus kawm ntawv, yuav yog cov menyuam ua yuav ntsib kev puas tsuaj thiab qhov kawg ces yuav xyaum mus ua neeg phem. Tej menyuam hluas lawv yuav txos lawv txoj kev vammeej thiab yuav pib muaj teeb meej rau lawv lub neeg.



Cov Lus Qhia Tawm

Ib tug menyuam twg yuav tsum mus kawm ntawv txhua hnuv thiab txhua hoob kom tiav hlov. Yog nws qhaj ib hnuv los yog ib nrab hnuv, cov niam txiv los yog tus neeg muaj cai saib xyuas tus menyuam yuav tsum hu qhia lubtsev kawm ntawv paub.

Lub Tsev Kawm Ntawv Txog Hauj Lwv

- Nrhiav kev pab/sijhawm mus pab cov menyuam txoj kev kawm ntawv.
- Nrhiav kev cob qhia kom cov menyuam paub lawv qhov peev xwm thiab kev kawm.
- Saib xyuas kom kev mus kawm ntawv kom yog thiab tej ntaub ntawv qhia rau niam txiv/tus mauj cai saib xyuas thiab tus menyuam txog kev mus kawm ntawv.

Kev Qhia Txog Menyuaum Kev Kawm Ntawv 12-15 Xyoo

Txoj kev cai tau “tsim muaj los pab tsev neeg thiab cov menyuam hauv tsev kawm ntawv thiab pab cov menyuam txob qhaj ntawv.”

Thaum tug menyuam qhaj txog 5 (*tsib*) *hnuv*, lubtsev kawm ntawv yuav tsum ceeb toom niam txiv los tus muaj cai saib xyuas tus menyuam paub “txhais tias nws yog ib tug pheej tsis mus kawm ntawv.” Tus menyuam thiab niam txiv yuav tau txais ib tsab ntawv los ntaum County Attorney’s Office.

Yog tus menyuam qhaj txog xya (7) *hnuv*, ce txhais tias nws yog ib tug “*pheej qhaj ntxiv*.” Lubtsev kawm ntawv yuav tsum xab tus menyuam rau Washington County tom qab nws qhaj txog 7-10 hnuv us tsis mus kawm ntawv.

Ib tug County Truancy Social Worker yuav teen caij nyoog nrog lubtsev kawm ntawv, cov niam txiv, thiab tus menyuam sib tham. Lub sijhawm sib tham no yog los pab ua zaum kawg siab tus menyuam puas mus kawm ntawv. Yuav tsim ib tsab ntawv cog lus nrog tus menyuam thiab nws yuav raug ib tus neeg hauv tsev kawm ntawv taug rawv nws qab. Tej kev txim txhaum kuj muaj rau lub sijhawm no thiab kev pab ntxiv los kuj muaj.

Kev Qhia Txog Menyuaum Kev Kawm Ntawv 16-17 Xyoo

Thaum tus menyuam qhaj txoj 5-7 *hnuv*, lubtsev kawm ntawv yuav tsum ceeb toom cov niam txiv los yog tus neeg muaj caj saib xyuas hais tais tus menyuaum yog ib tug “*tsis mus kawm ntawv*.” Menyuaum thiab niam txiv yuav txais ib tsab ntawv los ntaum County Attorney’s Office (kws lij choj). Menyuaum ua pheej qhaj ntawv yuav raug xa mus rau xam los ntawv tsev kawm ntawv.
