DATE: 1/8/2008
DEFENDANT: Stephen Wade Hop
DOB: 12/30/1976
CITY/RESIDENCE: Grant, MN
AGENCY: Washington County Sheriff's Office
CONVICTION: Driving While Cancelled-IPS
SENTENCE: The defendant was ordered to serve 90 days in jail and pay a \$1000 with 80 days and \$800 suspended for 1 year probation on the conditions that he have no same or similar offenses.

CITY/RESIDENCE: Burnsville, MN
AGENCY: Woodbury Police Department
CONVICTION: Offering a Forged Check
SENTENCE: The defendant was committed to the Commissioner of Corrections for 19 months with the execution stayed for up to 5 years probation on the following conditions: (1) serve 64 days in the Washington County Jail with credit for 64 days served, (2) pay a \$50 fine, (3) abstain from the use of all mood-altering chemicals and submit to random testing, (4) maintain employment, (5) obtain cognitive skills assessment, (6) attend South Oaks Gambling assessment, (7) provide a DNA sample, (8) cooperate with transfer of probation to County of residence.

AGENCY: Oakdale Police Department
CONVICTION: Controlled Substance Crime in the Fifth Degree
SENTENCE: Adjudication of sentence was stayed and the defendant was placed on probation for five years with the following conditions: 1) pay a \$50 fine plus surcharges; 2) complete a Cognitive Skills Programming evaluation and follow the recommendations; 3) complete all mental health programming, including taking all prescribed medications at the direction of the mental health professional; 4) continue chemical dependency treatment aftercare; 5) abstain from the use of all mood-altering chemicals, including alcohol, and submit to random testing; 6) attend AA/NA one time per week for 12 months and provide verification; 7) have no same or similar offenses, be law abiding and cooperate with all standard conditions of probation.

SENTENCE: The defendant was ordered to serve 365 days in jail and pay a \$3000 with 335 days and \$2500 suspended for 3 years probation with the following conditions: obtain chemical dependency evaluation and follow all recommendations, (2) have no same or similar offenses and remain law abiding, (3) the jail time to be served as 2 days straight time and 28 days on work release, the defendant can go to school in lieu of work
