CONVICTION: Fleeing a Peace Officer in a Motor Vehicle  
SENTENCE: Probation for three years under these conditions: serve three days jail with credit for three days served; pay \$500 fine plus surcharges; have no same or similar offenses, be law abiding and follow all the standard conditions of probation; abstain from mood-altering chemicals and submit to random testing, and provide a biological specimen for purposes of DNA analysis.

Time to be served under any alternative for which Defendant is qualified, including Community Work Service for 72 hours of the 9 days remaining. 2) Pay \$250 fine plus surcharges. 3) Abstain from the use of all mood-altering chemicals, including alcohol, and submit to random urinalysis/breathalyzers at her own expense. 4) Complete a psychological evaluation and follow all recommendations. 5) Have no same or similar offenses, be law abiding, and cooperate with all the standard conditions of probation.

Sign any and all releases for medical reports.
