DATE: 9/30/2009

DEFENDANT: Alexander Scott Christoff

DOB: 1/14/1984

CITY/RESIDENCE: White Bear Lake, MN

AGENCY: Washington County Sheriff's Office

CONVICTION: Aiding and Abetting Burglary in the 2nd Degree

SENTENCE: The defendant was committed to the Commissioner of Corrections for 33 months. Execution of sentence was stayed and the defendant was placed on probation for ten years with the following conditions: 1) one year jail, credit for 59 days, can be done on in-custody Sentence to Service; 2) pay restitution in the amount of \$12,877.67, joint and several, to the victim; 3) complete a cognitive skills evaluation and follow the recommendations; 4) abstain from the use of chemicals, including alcohol, submit to random testing; 5) seek and maintain gainful employment and provide verification to probation agent; 6) cooperate with the transfer of probation to county of residence; 7) no contact with Matt Secrest; 8) no same or similar offenses, remain law abiding; 9) pay a \$50 fine.

SENTENCE: The court committed defendant to the Commissioner of Corrections for 23 months and stayed the execution of sentence and placed the defendant on probation for 5 years under the following conditions: Successfully complete program at Place of Hope and follow all of their recommendations, serve 169 days w/credit for 169 days served, pay \$500 fine, follow standard conditions of probation, remain law abiding, abstain from the use of mood altering chemicals including alcohol and submit to random testing, baseline urinalysis today, cooperate with the transfer of supervision to county of residence, attend cognitive skills programming if available, provide biological specimen for purposes of DNA analysis.

He is to have no contact the victims, their family members or their places of business or residence and he is to provide a DNA sample.

SENTENCE: Imposition of sentence stayed and placed on probation for 10 years, under the following conditions: 1) serve 90 days in jail with credit for 6 days served, to be served on in-custody Sentence to Service, criteria waived; 2) no direct or indirect contact with the victim, or victims immediate family; 3) abstain from all mood-altering chemicals, including alcohol, and submit to random testing at own expense; 4) enter and complete sex offender treatment and follow all recommendations; 5) participate in and pay for any polygraph testing required; 6) no unsupervised contact with female minors, under the age of 18 years old, until it has been determined to be appropriate by a therapist; 7) follow all recommendations of the psycho-sexual evaluation; 8) follow all the standard conditions of the Sex Offender Unit; 9) no same or similar offenses, be law abiding, and cooperate with all the standard conditions of probation; 10) register as a predatory offender; 11) provide DNA sample per statute, and ordered to pay a fine of \$200 and fees plus surcharges.
