THE WEEK OF 9/22/2008**

DATE: 9/22/2008
DEFENDANT: Richard Santana
DOB: 3/7/1969
CITY/RESIDENCE: St Paul, MN
AGENCY: St. Paul Park Police Department
CONVICTION: 4th Degree Burglary
SENTENCE: The defendant was given 365 days jail and a \$3,000 fine. 345 days and \$2,500 were suspended with the following conditions: 1) 2 years probation; 2) remain law abiding.

DEFENDANT: John Manuel Contreras
DOB: 3/20/1988
CITY/RESIDENCE: St. Paul, MN
AGENCY: St. Paul Police Department
CONVICTION: Aiding and Abetting Receiving Stolen Property
SENTENCE: Court stayed imposition of sentence and placed defendant on probation for 10 years on following conditions: 1) Serve 30 days in jail with credit for time served, credit to be determined. Any time to be served on out-of-custody Sentence to Service. 2) Pay \$50 fine plus surcharges. 3) Pay restitution in an amount to be determined within 30 days of sentencing. Restitution to be paid joint and several with any co-defendants. 4) No contact with Scrap Metal Recovery in St. Paul, MN. 5) Abstain from the use of all mood-altering chemicals, including alcohol, and submit to random urinalysis/breathalyzers at own expense. Baseline to be provided at time of sentencing. 6) No same or similar offenses, be law abiding, and cooperate with all the standard conditions of probation. 7) Cooperate with the transfer of his supervision to his County/State of residence. 8) Provide a biological specimen for purposes of DNA analysis.

CONVICTION: Harassment; Violation of Restraining Order
SENTENCE: 12 months and one day in prison, consecutive to his current prison sentence; the fine and surcharge were waived; he must give a DNA sample; no contact with victim while the harassment/restraining order remains in effect.

AGENCY: Forest Lake Police Department
CONVICTION: 5th Degree Controlled Substance

SENTENCE: Court stayed adjudication of sentence and placed the defendant on probation for 5 years on following conditions: 1) Serve 5 days in jail with credit for 5 days served. 2) Pay \$50 fine plus surcharges. 3) Abstain from the use of all mood-altering chemicals, including alcohol, and submit to random urinalysis/breathalyzers at own expense, to begin once probation is transferred to county & state of residence. 4) Submit baseline urinalysis at time of sentencing. If results are positive, complete an updated chemical dependency evaluation, & follow any recommendations. 5) Have no same or similar offenses, be law abiding, and cooperate with all the standard conditions of probation. 6) Cooperate with the transfer of her supervision to her County/State of residence.

CONVICTION: Terroristic Threats
SENTENCE: The defendant was given 365 days jail and a \$3,000 fine. 275 days of the jail time was stayed and \$2,100 of the fine was suspended with the following conditions: 1) 3 years probation; 2) no contact with the victim; 3) complete a cognitive skills evaluation; 4) complete an anger management evaluation; 5) abstain from the use of alcohol and chemicals and submit to random testing; 6) attend AA one time a week for 6 months; 7) seek and maintain gainful employment; 8) remain law abiding; 9) provide a DNA sample.
