THE WEEK OF 7/26/2010**

DATE: 7/23/2010
DEFENDANT: Richard Allen Balsimo
DOB: 7/30/1946
CITY/RESIDENCE: Afton, MN
AGENCY: Washington County Sheriff's Office
CONVICTION: 5th Degree Criminal Sexual Conduct
SENTENCE: The court ordered the defendant to pay \$3000 fine and 365 days in jail with \$2800 and 275 days suspended for 3 years probation on the following conditions: 1) Serve 90 days in the Washington Co. Jail with credit for 5 days served. Time to be served on in- custody Sentence to Service, or work release, criteria waived. 2) Pay any restitution determined to be paid by the Minnesota Crime Victims Reparations Board. Restitution to remain open for one year. 3) Have no direct or indirect contact with the victims or their immediate family members (parents and siblings). 4) Abstain from the use of all mood-altering chemicals, including alcohol, and submit to random urinalysis/breathalyzers at his own expense, unless the supervising probation officer deems it unnecessary. 5) Comply with individual counseling treatment recommendations of the psycho-sexual evaluation by Dr. James Gilbertson; that he see a mature therapist to address issues. No viewing or use of pornography. 6) Have no contact with minor children under the age of 18, without an adult present, until approved by therapist and supervising probation officer. No overnight visits permitted. 7) Follow all the standard conditions of the Sex Offender Unit, unless the supervising probation officer deems it unnecessary. 8) Participate in and pay for any polygraph testing requested by therapist or supervising probation officer. 9) Have no same or similar offenses, be law abiding, and cooperate with all the standard conditions of probation. 10) Register as a predatory offender. 11) Provide a biological specimen for purposes of DNA analysis.
