DEFENDANT: Theodore John Larson

DOB: 11/1/1950

CITY/RESIDENCE: Lakeland, MN

AGENCY: Minnesota Alcohol and Gambling Enforcement Division

CONVICTION: Gambling

SENTENCE: Stayed the Imposition of Sentence and placed defendant on probation for 5 years on the following conditions: 1) Serve 30 days in jail with credit for 1 day served, to be served on in or out-of-custody Sentence to Service; 2) Pay \$250 fine; 3) Refrain from gambling in any form; 4) No same or similar offenses, be law abiding, and cooperate with all the standard conditions of probation; 5) Provide a biological specimen for purposes of DNA analysis.

SENTENCE: Stay of imposition of sentence, 5 yrs probation on following conditions: 1) Serve 58 days in jail with credit for 58; 2) Pay \$50 fine; 3) Obtain chemical dependency evaluation and follow all recommendations; 4) Abstain from the use of mood altering chemicals, including alcohol, and submit to random urinalysis/breathalyzers at own expense; 5) Complete an evaluation for Cognitive Skills programming; 6) Maintain gainful employment and provide verification; 7) No same or similar offenses, be law abiding, and cooperate with all the standard conditions of probation; 8) Provide a biological specimen for purposes of DNA analysis.
