

**SENTENCING FOR  
THE WEEK OF 4/12/2010**

DATE: 4/7/2010

DEFENDANT: Chris Carlton Atkins

DOB: 12/21/1966

CITY/RESIDENCE: ST PAUL, MN

AGENCY: Newport Police Department

CONVICTION: Count I - Check Forgery; Count II - Possession of Stolen or Counterfeit Checks

SENTENCE: Count I - Check Forgery: The defendant was committed to the Commissioner of Corrections for 15 months. Execution of sentence was stayed and the defendant was placed on probation for 10 years with the following conditions: 1) serve 90 days jail; 2) pay \$3,300 restitution to the victim; 3) remain law abiding and cooperate with the transfer of probation.

Count II - Possession of Stolen or Counterfeit Checks: The defendant was committed to the Commissioner of Corrections for 17 months. Execution of sentence was stayed and the defendant was placed on probation for 10 years with the same conditions as for Count I.

CONVICTION: Drugs in the 5th Degree

SENTENCE: The defendant was sentenced under a stay of imposition of sentence and placed on probation for 5 years, subject to the following conditions: (1) Serve 180 days in the Washington County Jail with credit for 153 days served; (2) Intensive Supervision if defendant becomes a Washington County resident; (3) Complete a chemical dependency evaluation and follow all recommendations; (4) Abstain from the use of all mood-altering chemicals; (5) Seek and maintain gainful employment; (6) Have no same or similar offenses, be law abiding, and cooperate with all of the standard conditions of probation; (7) Cooperate with the transfer of his supervision to his county of residence; (8) \$50 fine.

SENTENCE: The defendant was committed to the Commissioner of Corrections for 36 months. Execution of sentence was stayed and the defendant was placed on probation for five years with the following conditions: 1) serve 270 day jail; 2) 5 years probation on intensive supervision if he lives in Washington County; 3) complete a chemical dependency evaluation and follow the recommendations; 4) abstain from the use of alcohol and chemicals and submit to random

testing; 5) seek and maintain gainful employment; 6) complete a cognitive skills evaluation; 7) remain law abiding and cooperate with the transfer of probation to county of residence; 8) pay restitution joint and several with co-defendant.

SENTENCE: Committed to the Commissioner of Corrections for a period of 42 months and stayed the execution of sentence and placed on probation for a period of 7 years. Subject to a 5 year conditional release period. Placed on probation under the following conditions: 1) serve 180 days in jail with credit for 51 days served; may serve the time as a staggered sentence; must register for orientation for in-custody Sentence to Service by every April 12 each year and serve 14 days on in-custody Sentence to Service until served the 180 days; 2) abstain from the use of all mood-altering chemicals, including alcohol, and submit to random testing; 3) have no same or similar offenses, be law abiding, and cooperate with all standard conditions of probation; 4) provide a biological specimen for purposes of DNA analysis; 5) complete the Regions ADAP treatment program and follow all continuing care recommendations; 6) complete the repeat offender DWI program; 7) attend AA meetings four time per week for 6 months, and provide verification to the supervising probation officer; 8) complete an evaluation for Driving With Care class and follow all recommendations; 9) participate in long term monitoring that includes a minimum of 30 days of Electronic Home Monitoring to start on or about April 12 of each year of probation and it is in addition to any jail time served while on probation; the 30 days of Electronic Home Monitoring and when it should be served should be coordinate with probation; 10) comply with all mental health programming, including individual therapy; 11) pay a \$50 fine plus surcharges.

SENTENCE: The defendant was sentenced under a stay of adjudication of sentence pursuant to 152.18 and placed on probation for a period of 5 years, subject to the following conditions: (1) Serve 1 day in the Washington County jail with credit for 1 day served; (2) Complete all mental health programming, including taking all prescribed medication; (3) Abstain from the use of all non-prescribed mood-altering chemicals, including alcohol, and submit to random urinalysis/breathalyzers at her own expense; (4) Seek and maintain volunteer work; (5) Have no same or similar offenses, be law abiding, and cooperate with all standard conditions of probation; (6) Cooperate with transfer of her supervision to her county of residence; (7) Fine of \$100 and surcharges.

SENTENCE: Court stayed the adjudication of sentence pursuant to 152.18 and placed the defendant on probation for a period of 5 years under the following conditions: 1) serve 59 days in jail with credit for 59 days; 2) complete an evaluation for cognitive skills programming and follow all recommendations; 3) complete aftercare at the direction of the continuing care plan; 4) abstain from the use of all mood-altering chemicals, including alcohol, and submit to random testing; 5) attend AA/NA meetings two times a week for 12 months and provide verification to the supervising probation officer; 6) seek and maintain gainful employment and provide verification to the supervising probation officer; 7) complete a mental health evaluation and follow all recommendations; 8) have no same or similar offenses, be law abiding, and cooperate with all the standard conditions of probation; 9) pay a \$50 fine plus surcharges.
