DEFENDANT: Tramaine Davis

CONVICTION: Felony Domestic Assault
SENTENCE: The Court stayed the imposition of sentence and placed Defendant on probation under the supervision of Washington County Community Corrections for a period of 5 years, subject to the following conditions: (1) Serve 60 days in the Washington County Jail with credit for 3 days served, time to be served on out-of-custody Sentence to Service, if qualified; (2) Complete 6-week Domestic Violence Program and provide verification to the supervising probation officer (within 15 days of sentencing); (3) Complete a chemical dependency; (4) Abstain from the use of all mood-altering chemicals, alcohol and submit to random urinalysis/breathalyzers at his own expense; (5) Have no same or similar offenses, be law abiding, and cooperate with all standard conditions of probation; (6) Cooperate with the transfer of his supervision to his county of residence; (7) Provide a biological specimen for purposes of DNA analysis; (8) No contact with victim.

SENTENCE: \$3,000 fine and 365 days in jail, with \$2,950 and 305 days suspended for two years on the following conditions: (1) two years' probation; (2) pay a \$50 fine, which is to be deducted from the \$1,000 cash bail posted; (3) remain law abiding, and be of good behavior; (4) have no same or similar offenses; (5) serve 60 days in jail under the Huber Release Program, and criteria were waived; (6) obtain a mental health evaluation and follow all recommendations; (7) provide verification of completion of the anger management program at Washington County Human Services, Inc.; (8) cooperate with the conditions of probation set forth in the probation agreement, and (9) provide a biological specimen for DNA analysis.

SENTENCE: The Court sentenced the defendant under a stay of adjudication and placed the defendant on probation for a period of 5 years, subject to the following conditions: (1) Serve 30 days in the Washington County Jail with credit for 5 days served, time to be served on weekends; (2) Obtain any prescribed narcotic pain medications from one prescribing physician and sign all releases for communications between physician and Washington County Community Corrections; (3) Complete outpatient chemical dependency treatment and follow all recommendations, including aftercare; (4) Abstain from the use of all mood-altering chemicals, including alcohol, and submit to random urinalysis/breathalyzers at his own expense. Defendant allowed to provide blood tests via mobile testing, paid for by defendant; (5) Have no same or similar offenses, be law abiding, and cooperate with all the standard conditions of probation; (6) \$100 fine plus surcharges.

management, domestic abuse treatment program, or a long-term DBT class; 4) abstain from the use of mood altering chemicals, including alcohol, and submit to random urinalysis at own expense; must give a baseline urinalysis today and must abide by the order for protection in effect, until that order is vacated by the victim; 5) attend out-patient treatment program within 30 days, and follow all recommendations for programming; 6) have no same or similar offenses, remain law abiding, and cooperate with probation; 7) have no assaultive behavior; 8) may not possess any weapons during the period of probation; 9) must provide a biological specimen for DNA analysis; and 10) must pay a \$100 fine and surcharges.
