Transportation Resources for Washington County Residents

If you need transportation, and you live in Washington County, you have a variety of options available to you. Transportation fees and fares will vary with each service provider and many require some advance notice to schedule a ride. Other transportation services exist that may not be included here. Check your local phone directory for more information.



American Cancer Society—651-255-8100

Transportation provided to cancer patients who are ambulatory and need rides to doctor appointments and medical treatments. The Road to Recovery Program uses volunteer drivers. Five business days advance notice is encouraged.

Blue Cross Blue Shield Blue Ride—651-662-8648

A service to BluePlus members who are ambulatory. Transportation provided to medical, dental, physical therapy or eye exams.

Three business day advance notice is needed to schedule a ride.

Community Thread(formerly Community Volunteer Service and Senior Centers) - **651-439-7434**

Transportation provided by volunteer drivers to medical appointments for persons who are ambulatory with no other means of transportation. Minimum of three business days advance notice is needed. Donations are accepted.

Dial-A-Ride—612-278-2539. Provides a shared ride service in several metro area cities. Some buses go to other cities. There is a fare. One day notice needed with limited same day availability. See below for local Dial-A-Ride services.
