DEFENDANT: Paul Charles Kaldenberg

CONVICTION: Traffic - DWI - Operate Motor Vehicle Under Influence of Alcohol
SENTENCE: Court sentenced the defendant to 365 days with 335 days stayed, credit for 1 day served; \$3,000 fine with \$2500 stayed; 4 years probation; no same or similar offenses and remain law abiding; jail time to be served on work release, can be served in Polk County, WI, report by 12/1/12; obtain chemical dependency evaluation in WI and provide copy to Washington County Community Corrections within 30 days; attend a MADD panel; no use of drugs or alcohol; probation can determine when testing occurs; cooperate with the transfer of probation to WI.
