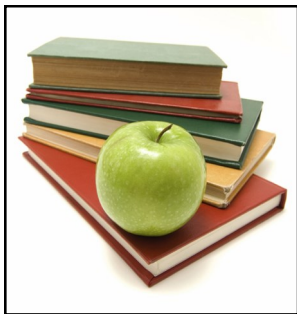


## Lub Raws li txoj cai rau txim ntawm kev kawm Tsis Saib Xyuas

Ib tug me nyuam tiv thaiv cov kev pab cuam kev ntsuam xyuas kom tiav thiab yog tias kev kawm ntawv tsis saib xyuas yog txiav txim tias yuav muaj ntxiv County kev koom tes; xws li ib rooj plaub los sis kev cai lij choj hais plaub ntug.
- Cov niam txiv yuav tsum thov kom tsev hais plaub rau kev kawm Tsis Saib Xyuas.
- Cov niam txiv yuav tsum tau koom tes nyob rau hauv cov me nyuam chav kawm ntawv, kev pab tswv yim zaug, los yog lwm yam kev pab uas tsim los pab lawv nyob rau hauv kev txhim kho lawv cov me nyuam lub tsev kawm ntawv tuaj kawm ntawv.
- Nyob rau hauv huab, cov me nyuam yuav tau muab tshem tawm los ntawm lawv cov niam txiv hauv tsev thiab muab tso rau hauv niam qhuav txiv qhuav los yog nrog lwm tus neeg laus hauv tsev neeg.
- Yog hais tias tus me nyuam yog nyob rau hauv kev xav tau ntawm kev pab tshwj xeeb los yog kev kho mob lub tsev hais plaub tej zaum yuav txiav txim kom hais tias nws yuav muab.



## Lub Tswv Yim Rau Kom Kev Mus Kawm Ntawv

- Qhia rau koj tus me nyuam hais tias lawv kev kawm ntawv yog ib qho tseem ceeb rau koj.
- Muaj ib tug txheej yuav mus pw thiab thaum sawv ntxov niaj hnub uas muaj xws li noj tshais.
- Sib txuas lus nrog lub tsev kawm ntawv; kom paub tseeb tias koj paub lub tsev kawm ntawv txoj cai.
- Teem lub expectation tias koj cov me nyuam ua kom tiav lawv cov ntawv ua tom tsev txhua txhua hnub.
- Pab koj tus me nyuam nrog lawv ua tom tsev.
- Yog hais tias koj tus menyuam tsis xav mus kawm, nug yog vim li cas thiab pab tau lawv kho tej.
- Nrhav kev pab rau tej teeb meem uas tej zaum yuav teeb liab ntsais nws /nws mus kawm lub tsev kawm ntawv, xws li nyiaj txiag los yog tsev neeg tej teeb meem, kev puas siab ntsws noj qab haus huv tej teeb meem, los yog lub cev kev noj qab nyob tej teeb meem.

## Kev Mus Kawm Ntawv: Nws Yog Kev Cai Lilj Choj

Tag nrho cov me nyuam muaj hnub nyoog 5 thiab 6, (yog tias kawm nyob rau hauv ib tug pej xeem lub tsev kawm ntawv) thiab cov me nyuam muaj hnub nyoog 7-18 yuav tsum tuaj mus kawm ntawv txhua txhua hnub ntawd lawv lub tsev kawm ntawv yog nyob rau hauv kev sib kho. Los ntawm Minnesota State Pej thuam, ib tug me nyuam yog nyob rau hauv kev xav tau ntawm kev tiv thaiv los yog kev pab thaum ib tug me nyuam yog tsis muaj qhov tsim nyog zaub mov, khaub ncaws, vaj tse, **thiab kev kawm ntawv**, los yog lwm yam yuav tsum tau kho mob rau cov me nyuam lub cev los yog kev puas hlwb kev noj qab haus huv los yog kev ua vim hais tias tus me nyuam niam thiab txiv, tus saib xyuas, los yog tus saib tsis tau los yog tsis kam mus muab tau cov kev kho mob.

## Txhais cov ntsiab lus

## Educational Tsis Saib Xyuas Intervention Services

Cov tsev kawm ntawv yuav tsum tau ua cov kev mus daws cov tub ntxhais kawm kawm ntawv tej teeb meem nrog cov tsev neeg. Yog hais tias muaj teeb meem ntxiv rau lub tsev kawm ntawv muaj peev xwm xa ib tug xa mus rau Washington County thaum ib tug me nyuam kawm ntawv accumulates tsawg kawg yog 3 tab sis tsis muaj ntau tshaj li 6 zaug.

Thaum lub sij hawm ntawm xa mus rau Social Services, kev pab no yog tsim los rau qhov chaw nyob tuaj mus kawm ntawv tej teeb meem ua ntej mus rau ib tug me nyuam tiv thaiv kev xa mus, muab lub tsev neeg ib lub sij hawm los mus ua kom tsim nyog hloov mus kho qhov teeb meem.

Ib tug Washington County Social Worker yuav teem ib lub rooj sib tham nrog lub tsev kawm ntawv thiab niam txiv (s) los tsim ib tug ntawv cog lus nyob rau hauv uas cov niam txiv (s) pom zoo nyob rau tej teeb meem impacting lawv tus me nyuam lub tsev kawm ntawv kev tuaj kawm, thiab los xyuas kom meej rau lawv tus nyuam txoj kev mus kawm rau qhov seem ntawm lub tsev kawm ntawv xyoo.

Xya zaug poob nyob rau hauv lub xeev cov kev cai rau kev kawm tsis saib xyuas, thiab yog li ntawd xa mus rau tus me nyuam tiv thaiv. Kho qhov teeb meem tuskheej lub xav tau rau ib tug me nyuam tiv thaiv kev tshawb nrhiav.

## Lub luag hauj lwm ntawm lub Tsev Kawm Ntawv

- Muab ib qho kev pab / lub sij hawm uas muaj raws li qhov tus nyuam kawm ntawv txoj kev kawm xav tau kev pab.
- Chaw nyob teeb meem pom tau tias raws li tej t o tus me nyuam txoj kev muaj peev xwm mus koom thiab kawm.
- Tswj tseeb tuaj mus kawm ntawv cov ntaub ntawv thiab daim ntawv kev sib txuas lus nrog cov niam txiv / cov saib xyuas thiab cov tub ntxhais kawm txog kev mus kawm ntawv.

## Lub luag hauj lwm ntawm Niam Txiv

- **Qhia** kom koj tus nyuam mus kawm s chool txhua txhua hnub.
- Xyuas kom koj tus me nyuam tau ua tiav qhov yuav tsum tau ua tom tsev.
- Saib xyuas koj tus me nyuam mus kawm ntawv thiab kev kawm nyob rau hauv tsev kawm ntawv.
- Sib txuas lus nrog lub tsev kawm ntawv thaum koj tus me nyuam tej zaum yuav xav tau kev tsis mus kawm ntawv rau ib tug siv tau yog vim li cas.
- Mus koom ib lub rooj sib tham nrog rauj koj tus me nyuam thiab ua raws li cov tswv yim pom zoo o f daim ntawv cog lus. Hu rau lub Social Worker yog hais tias tus ntawv cog lus tsis ua raws li.
