Subject: Washington County Licensing Info on COVID-19

Thank you for your continued work with the children and vulnerable adults of Washington County. The leadership teams at Washington County continue to monitor the spread of COVID-19 and evaluate the implications of the virus on county business and the work you do with our community members.

At this time, there are no significant changes to county operations. We do, however, understand the need to monitor the recommendations from the Minnesota Department of Health and the Washington County Public Health and Environment Department. The Washington County Licensing Unit is also in contact with the Licensing Department at the Department of Human Services. They continue to have discussion on the implications of COVID-19 and will communicate with all counties as they receive information and make decisions.

The precautions recommended by health officials at this time continues to be:

1. Wash your hands thoroughly with soap and water.
2. Stay home when you are sick. If you, family members, or the children are sick and have a licensing visit, please call your licensor to reschedule.
3. Cover your cough.
