Tus me-nyuam kawm ntawv thiab lawv niam lawv txiv yuav ua tau p etitioned rau lub tsev hais plaub raws li ib tug me nyuam nyob rau hauv kev xav tau ntawm kev tiv thaiv los yog kev pab raws li nyob rau kev qhaj ntawv. - Ib tug me nyuam tej zaum yuav poob lawv cov tsav tsheb cai kom txog rau thaum nws los yog nws yog 18 xyoo.

Kev Mus Kawm Ntawv: Nws yog kev cai lij choj

Minnesota txoj cai Statute yuav tsum tau uas cov me nyuam mus kawm lub tsev kawm ntawv.

Qhaj zaum yog ib tug ua txhaum ntawm Minnesota lub xeev txoj cai lij choj. Cov niam txiv, tsev kawm ntawv, thiab neeg zej zog yeej tag nrho cov neeg koom tes nyob rau hauv kev ua hauj lwm mus rau lub hom phiav ntawm lub tsev kawm ntawv mus kawm ntawv thiab kev kawm ntawv kawm tau zoo.

Kev kawm ntawv yog raws li tseem ceeb raws li zaub mov, khaub ncaws thiab tsev nyob nyob rau hauv ib tug me nyuam lub neej. Cov niam txiv yuav tsum xa lawv cov me nyuam mus kawm ntawv los mus txhim kho cov me nyuam lub neej zoo.

Cov kev cai lij choj kuj hais tias kom cov niam txiv yuam lawv cov me nyuam mus kawm lub tsev kawm ntawv. Cov me nyuam yuav tsis ntawm nws tus kheej "poob tawm" ntawm lub tsev kawm ntawv. Qhaj zaum thiab pluag tuaj kawm yog lub p rimary yog vim li cas cov tub ntxhais kawm ua tsis tau kawm tiav o n lub sij hawm.

Ib tug nyuam kawm twg yuav tsum tau mus kawm lub tsev kawm ntawv txhua tus thiab txhua txhua hnuv thiab txhua tus thiab txhua txhua chav kawm ntawv lub sij hawm. Yog hais tias lawv tsis muaj tsev kawm ntawv ib hnuv los yog ib feem ntawm lub hnuv, rau tsim nyog yog vim li cas, ib tug niam txiv los yog tus saib xyuas yuav tsum tau qhia lub tsev kawm ntawv.

- Muab ib qho kev pab / lub sij hawm uas muaj raws li cov nyuam kawm ntawv kev kawm xav tau kev pab.
- Ib tug ddress teeb meem pom tau tias raws li tej tus me nyuam txoj kev muaj peev xwm mus koom thiab kawm.
- Tswj tseeb tuaj mus kawm ntawv cov ntaub ntawv thiab daim ntawv kev sib txuas lus nrog cov niam txiv / cov saib xyuas thiab cov tub ntxhais kawm txog kev mus kawm ntawv.

Tuaj Kawm Ntawv lub rooj sib tham Intervention (AIM)

Txoj cai yog "tsim los pab rau ib tug pab kev cuam tshuam thiab cov kev pab cuam los txhawb cov tsev neeg thiab cov me nyuam nyob rau hauv tsev kawm ntawv thiab nyob rau hauv combating kev qhaj ntawv."

AIM stands rau Attendance Intervention rooj sib tham. Qhov no yog thawj kauj ruam ntawm hnyav pab thiab cov kev pab cuam uas muaj rau cov tsev neeg txhawb thiab cov me nyuam nyob rau hauv kom cov me nyuam nyob rau hauv tsev kawm ntawv thiab combating kev qhaj ntawv.

Thaum 3-5 zaug, lub tsev kawm ntawv mam ceeb toom rau niam txiv los yog tus neeg saib xyuas tias tus me nyuam yog ib tug "txuas ntxiv qhaj ntawv". Cov nyuam kawm ntawv thiab cov niam txiv yuav tau txais ib tug caw los ntawm lub County Attorney lub chaw ua hauj lwm mus rau ib Attendance Intervention lub rooj sib tham (AIM).

Rauj

Yog hais tias tus me nyuam muaj 7 zaug, lawv yog ces xam tau tias yog "tais qhaj ntawv". Lub tsev kawm ntawv yuav tsum hais qhia cov tub ntxhais kawm ntawv rau Washington County tom qab 7-10 zaug.

Washington County npaj muaj ib txoj kev lub rooj sib tham ntawm lub tsev kawm ntawv, cov niam txiv, thiab tus me nyuam. Qhov no lub rooj sib tham tshwm sim nyob rau lieu of lub tsev hais plaub, nyob rau hauv kawg dag zog los mus yuam tus me nyuam mus kawm lub tsev kawm ntawv. Ib tug tuaj kawm daim ntawv cog lus yog tsim los nrog tus me nyuam thiab nws los yog nws yog muab tso rau hauv kev saib xyuas mus koom lub tsev kawm ntawv. Tseem Ceeb txim yuav tshwm sim nyob rau theem no thiab tsim nyog muab kev pab xa mus cuag tau.
